## **President's Report**

- ACT 49 of 2024. This act allows local governments the option to amend their police
  pension ordinance to allow full-time vested police officers the option to purchase up to
  five years of pension service credit, for prior full-time or part-time service with another
  department or other law enforcement entity. This Act went into effect on Sept 6<sup>th</sup>.
- We received the 2024 Municipal Pension State Aid in September, the amount deposited into General was \$50,332.44. This is an increase from 2023 (\$27K). This is due to hiring Joe FT. Police are double. The amount received covers the amount due to PMRS, paid \$33,182 10/1. The amount remaining is \$17,150.44.
- Butler Township is wanting to know if there will be any upgrades to sewer in the next few years. Can you please advise if there are any plans of upgrades to sewer.
- Kelly checked with Xfinity Mobile on cell phone coverage. It will be more expensive to switch. Our current plan is \$162/month, Xfinity would be around \$180/month. Xfinity also does not provide air cards for hotspots for the police cars. We will need to purchase cell phones for the police cars to provide hotspots for the police laptops that remain in the cars. Just an FYI....
- Please review the attached uniform policy. This item is not on the October agenda. This is for council to review and advise of any changes. This will be on the November agenda to make a motion to adopt the policy.
