In April our water system pumped a total of 2,444,000 gallons averaging 81,467 gal/day. That is a 1.9 % decrease from March 2024 and a 8.2 % decrease from April 2023.

April's bacteria samples were taken on the 3rd at 366 Arendtsville Road (Nutrien), 38 West York Street (Adams County Surplus), 374 Heidlersburg Road (G.V.M). Also, the same day second quarter Well #5 PFAS samples were taken. On the 10th Well #7 PFAS samples and Well #6 PFAS were taken on the 17th.

In April had one final water meter reading, 146 South Main Street.

In April the 2023 C.C.R. was completed. Doug, Kelly and Kelly Marie prepared, mailed it out to the customers and sent it to the PA.D.E.P.

On April 24th, Ault Paving did the final paving restoration at 124 South Main Street water leak repair.

On the week April 15th, Chris Minter Sealcoating, sealed the driveways at the water storage tank on Yellow Hill, wells #6 & #7 and the access driveway to the detention pond off on Hillcrest Drive.

We been having trouble with some of our trucks, Bob Guise replaced the clutch slave cylinder on the 87 G.M.C. dump truck. The 97 Dodge is out at A.J.K. Repair (25 Third Street). the throw out bearing went out it. Kevin can tell the details on that. The 02 Ford been at Myers Electric with electrical problems a couple times. Doug thinks it's time to talk about replacing the 02 Ford.

Water /Wastewater Operator Doug Hays

 Ecker asked Bollinger what the issues are with the vehicles. Bollinger responded to say that the 02 Ford was an electrical issue that has been fixed, the 97 Dodge is a throw out bearing and it's been noisy for a long time. Bollinger reported that AJK repair is getting ready to put the transmission back in the Dodge and it should be ready in the next week or so.
